The **Area IV Offshore Series** consists of the best three of four results in the Tripp Memorial Race, the Queens Cup, the HTYC Clipper Cup, and the AMYC Anchorage Cup. Awards by section (Area IV assigned, not event) and overall. Low point scoring relative to only boats in this series.

The **Area IV Shoreline Championship** consists of the best four of five finishes by class in the SHYC Invitational, the MBYC Commodore’s Cup, the GRSC Commodore’s Invitational, the MYC Governor’s Cup, and the AMYC Anchorage Cup. High point scoring by event section. Overall awards.

The **Area IV Boat of the Year Series** consists of the best six of eight results in the SHYC Invitational, the MBYC Commodore’s Cup, the GRSC Commodore’s Invitational, the MYC Governor’s Cup, and the four races of the Offshore Series listed above. High point scoring by event section. Overall awards.

The **Area IV Lake Michigan Championship** consists of the best six of eight results in the SHYC Invitational, the Chicago NOOD, the Tripp Memorial, the Queen’s Cup, the Chicago Mac, the MBYC Commodore’s Cup, the Chicago Verve Cup, and the MYC Governor’s Cup. High point scoring by event section. Overall awards.
